This supplement (the ‘**Supplement**’) constitutes a supplement for the purposes of Regulation (EU) 2017/1129, as amended (the ‘**Prospectus Regulation**’) and is supplemental to, forms part of and should be read in conjunction with:

- (i) the registration document dated 8 May 2023, as supplemented by the supplements dated 31 August 2023 and 4 December 2023, (the ‘**Registration Document**’) of Van Lanschot Kempen N.V. (the ‘**Issuer**’);
- (ii) the base prospectus consisting of separate documents (comprising the Registration Document and a securities note dated 11 May 2023), as supplemented by the supplements dated 31 August 2023 and 4 December 2023, in relation to the Issuer’s EUR 5,000,000,000 Covered Bond Programme (the ‘**Base Prospectus dated 11 May 2023**’);
- (iii) the base prospectus consisting of separate documents (comprising the Registration Document and a securities note dated 25 May 2023), as supplemented by the supplements dated 31 August 2023 and 4 December 2023, in relation to the Issuer’s EUR 2,500,000,000 Conditional Pass-Through Covered Bond Programme (the ‘**Base Prospectus dated 25 May 2023**’);
- (iv) the base prospectus consisting of separate documents (comprising the Registration Document and a securities note dated 23 June 2023), as supplemented by the supplements dated 31 August 2023 and 4 December 2023, in relation to the Issuer’s EUR 5,000,000,000 Debt Issuance Programme (the ‘**Base Prospectus dated 23 June 2023**’);
- (v) the base prospectus consisting of separate documents (comprising the Registration Document and a securities note dated 23 June 2023), as supplemented by the supplements dated 31 August 2023 and 4 December 2023, in relation to the Issuer’s EUR 2,000,000,000 Structured Note Programme for the issuance of Index and/or Equity Linked Notes dated (the ‘**second Base Prospectus dated 23 June 2023**’).

The Base Prospectus dated 11 May 2023, the Base Prospectus dated 25 May 2023, the Base Prospectus dated 23 June 2023 and the second Base Prospectus dated 23 June 2023 are together referred to as the ‘**Base Prospectuses**’ and each as a ‘**Base Prospectus**’.

This Supplement is prepared in connection with the publication of the Issuer’s press release of 21 December 2023 announcing the next step in its growth strategy in Belgium by acquiring Accuro.

The Registration Document and the securities notes of the Base Prospectuses have been approved by the Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*) (the ‘**AFM**’).

This Supplement has been approved by the AFM as competent authority under the Prospectus Regulation and published in electronic form on the Issuer’s website:

Terms used but not otherwise defined in this Supplement shall have the same meaning as ascribed to them in the Registration Document and the relevant Base Prospectus. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Registration Document or the relevant Base Prospectus by this Supplement and (b) any other statement in or incorporated by reference in the Registration Document or the relevant Base Prospectus, the statements in (a) above will prevail.

The AFM only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. In addition, the AFM shall provide ESMA with a copy of this Supplement.

RECENT DEVELOPMENT

On 21 December 2023, the Issuer published a press release announcing the next step in its growth strategy in Belgium by acquiring Accuro. In connection herewith, the Issuer wishes to supplement the Base Prospectuses and the Registration Document.

AMENDMENT TO THE REGISTRATION DOCUMENT AND TO THE BASE PROSPECTUSES

- A. The list of documents deemed to be incorporated by reference in, and to form part of, the Registration Document in the chapter ‘Documents Incorporated by Reference’ on page 23 of the Registration Document shall be amended by adding a new item (f) at the end thereof which reads as follows:

“(f) a press release of the Issuer dated 21 December 2023 entitled: Van Lanschot Kempen takes next step in growth strategy in Belgium by acquiring Accuro (except for page 2 thereof):

- B. A new paragraph shall be added in the chapter ‘Van Lanschot Kempen N.V.’ on page 31 of the Registration Document, at the end of the section headed ‘Recent Developments’ and directly above the heading ‘Governmental, legal or arbitration proceedings’, which reads as follows:

“Accuro Transaction

On 21 December 2023, the Issuer announced that the Issuer and the shareholders in Belgian investment adviser Accuro have reached agreement on the acquisition by the Issuer of Accuro NV.

Upon completion of the transaction, Accuro’s clients and employees will be integrated into Mercier Van Lanschot, further expanding its offering and expertise for clients in Belgium, in particular in terms of investment advice. Accuro’s founders will continue to be affiliated to Mercier Van Lanschot until 2030 at least.

The transaction is subject to regulatory approvals and is expected to have a negative impact of 0.4 percentage points on the Issuer’s capital ratio. The Issuer will pay 60% in cash and 40% in existing shares for the acquisition, locked up until 2030. Upon completion of the acquisition, Accuro is expected to be fully integrated into Mercier Van Lanschot from early 2025.”
