Van Lanschot Kempen: update on share buy-back programme 19 June 2018 – 25 June 2018

In the period from 19 June 2018 until 25 June 2018 Van Lanschot Kempen has repurchased 53,579 of its own shares (depositary receipts for Class A ordinary shares). The shares were repurchased at an average price of €24.91 per share for a total amount of €1,334,436.

These repurchases are part of the share buy-back programme for at most 400,000 of own shares, which was announced on 22 February 2018. The total number of shares repurchased to date is 357,510.
