

Casestudy: Fewer wildfires, more biodiversity



Investment case overview

Wildfires ravage large parts of the western and southern United States every year. Tens of thousands of hectares of forest are reduced to ashes, and the flames increasingly spread to populated areas. The infernos around Los Angeles in early 2025 are still fresh in many people's minds. These fires are not only a human tragedy but also devastating for nature and biodiversity.

Kempen's Private Global Impact Solution (PGIS) invests in Vibrant Planet through the Ecosystem Integrity Fund, a U.S.-based company that aims to prevent wildfires and strengthen ecosystems through an Al-enabled land management platform.¹

They do this with a unique cloud platform (Land Tender™) that proactively models risks and improves forest management using advanced AI and big data. Vibrant Planet operates in 8 states and manages over 30 million hectares of forest land.

Highlights

Fewer fires, more biodiversity

Vibrant Planet helps prevent catastrophic wildfires by intervening early and strengthening nature. In Placer County (California), one of the highest fire risk counties in the US, a plan for 20,000 acres was developed in just 14 weeks using the cloud platform – reducing fire risk while improving water security, biodiversity, and carbon storage. Normally, such a plan would take years.

Al-driven approach

Vibrant Planet's strength lies in its smart software. The Land Tender platform is a decision support system that uses satellite imagery, LiDAR data, and machine learning to map forest health and fire risk. This enables faster, more precise, and collaborative forest management: stakeholders work together in one dashboard on a shared land management plan.

Fund-of-funds access to innovation

PGIS invests through a fund-of-funds structure and holds a stake in Vibrant Planet via the Ecosystem Integrity Fund (EIF). EIF is a venture capital fund focused on early-growth companies that contribute to sustainability and climate resilience – exactly why it supported Vibrant Planet early on. Through EIF, PGIS can gain access to these kinds of innovative private companies.

Key points

Advanced Al software:

A unique platform that predicts wildfire hotspots and optimises forest management through artificial intelligence and big data analytics.

Focus on climate resilience:

Targets drought- and fire-prone forest regions in the United States, enabling nature and local communities to strengthen their resilience to extreme weather events more rapidly.

Commercial scalability:

Vibrant Planet offers its platform via a Software-as-a-Service (SaaS) licence on a per-hectare basis, making its business model replicable, scalable, and predictable. Its client base is expanding and includes government bodies, conservation organisations, and corporates. Furthermore, Vibrant Planet is able to quantify the ecological benefits of improved forest management in clear economic terms.

Strong partnerships:

The company has raised approximately 34 million US dollars in venture funding (led by EIF, with Microsoft among the investors).

Dual value proposition:

Aims for both ecological impact (such as reduced CO₂ emissions and forest preservation) and financial returns.

Kempen's Private Global Impact Solution is an SFDR 9 impact strategy focused on investments in Climate & Nature and Inclusive Growth. The investment in EIF (and through EIF in Vibrant Planet) strongly contributes to the first theme, specifically biodiversity conservation and enhancing nature's resilience to climate change.
