Van Lanschot Kempen: update on share buy-back programme 27 March 2018 – 29 March 2018

In the period from 27 March 2018 until 29 March 2018 Van Lanschot Kempen has repurchased 7,037 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €25.26 per share for a total amount of €177,766.

These repurchases are part of the share buy-back programme for at most 400,000 of own shares, which was announced on 22 February 2018. The total number of shares repurchased to date is 77,700.
