Van Lanschot Kempen: update on share buy-back programme 5 June 2018 – 11 June 2018

In the period from 5 June 2018 until 11 June 2018 Van Lanschot Kempen has repurchased 36,144 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €24.63 per share for a total amount of €890,244.

These repurchases are part of the share buy-back programme for at most 400,000 of own shares, which was announced on 22 February 2018. The total number of shares repurchased to date is 265,688.
