## COMMERCIAL PAYMENTS

*In principle we do not want to act as entry point for payments intended to beneficiaries who do not hold an account with Van Lanschot Kempen Wealth Management NV. or its subsidiaries outside The Netherlands.*

### **Other commercial payments**

When your instructions indicate that charges are to be for your account (OUR) we will claim a fixed fee of EUR 20,00 for each received MT103.

**Payments to banks** Subject to bilateral arrangement

### **FATF VII:**

*The 'EU Regulation on payer information accompanying transfers of funds' requires that information of the originator is included in payment instructions. Intra-EU payments must include name and IBAN (or unique identification nr). The address may be substituted by the originator's date and place of birth, a customer identification-nr or a national identity-nr. A payment to/from outside EU requires payer's full name+address in addition to the account number. This information should be in field 50 of the MT103.*

*For enquiries necessary as a result of the ordering bank's non-compliance with FATF7 requirements we will apply an enquiry fee as indicated below under 'ENQUIRIES'.*

## **AMENDMENTS / CANCELLATIONS**

*(Note that if the payment has already been advised to the beneficiary, the beneficiary's consent is necessary.)*

**If the SWIFT cancellation message reaches us:**

- on or before the value date €50,--
- after the value date €100,-- (administration fee as per European Interbank Compensation Guidelines)

## **ENQUIRIES**

**Enquiries lodged within 3 months from date of entry** €50,--

(in case of errors or omissions on our part: nil)

**Enquiries lodged after 3 months from date of entry** €75,--

(in case of errors or omissions on our part: nil)

*Enquiries lodged after 1 year from date of entry will be dealt with on a best effort basis, whereas enquiries lodged after 5 years from date of entry will be refused. For these enquiries and for other enquiries, which entail extraordinary extensive correspondence or other additional work or unusual responsibility, we reserve the right to require an additional commission for the special handling.*
